



Nishith Desai Centre for Thought Leadership in International Taxation has organised a course on international tax law. This will be available to a maximum of 15 students across all participating universities.

Nishith Desai Associates has established the Nishith Desai Centre for Thought Leadership in International Taxation ("NDCIT"). As part of the NDCIT's first initiative, a 2-week course is being organised at their research campus at Alibaug from 31 July to 12 August 2023.

This course has been created and will be taught by Dr. Dhruv Janssen-Sanghavi. Besides being a well-known academic in the field, he also leads our International Tax Practice from the Netherlands.

The course will cover the following modules through 80 contact hours of intensive learning:

Comparative International Aspects of Domestic Taxation; and Tax Treaties.

There will be two 4-hour examinations during the course, the passing mark for which will be a 6 (out of 10).

The course entails the following:

1. The university invites its students to apply for the course by writing a letter of motivation and sharing their law school transcripts so far;
2. awarding course credits upon successful completion of the course.
3. NDA shall arrange, gratis, for the students' board and lodging at Alibaug for the duration of the course.

Eligibility

Students who have completed at least one direct tax law course at law school are eligible to apply for the course. There will be offered to the top students of this course the opportunity of doing an assessment internship at NDA, the successful conclusion of which should result in a pre-placement offer to work at our firm.

The firm has requested to please accept their invitation and confirm participation no later than 15 May 2023.
